March 26, 2020

Friday Memorial Library values our community and our overall well-being so is taking precautionary measures as directed by the Center for Disease Control and Prevention (CDC). As part of these concerns, we are focusing on social distancing, reducing exposure, and enhanced sanitization.

While the health and safety of our community is our utmost concern, currently, the Library aims to remain open during regularly scheduled hours. However, we will be closed on Friday, March 20, 2020 for a thorough cleaning. Effective immediately, all library programs, events and outreach services are cancelled. This also includes any scheduled meetings being held in our meeting room.

The following are other precautions that we are undertaking to ensure a safe environment:

- All toys have been removed from the children's area
- Headphones have been removed from computer stations
- Limited public computer stations and seating is available

We are asking our library patrons, staff and volunteers to follow the advice of health experts. Please stay home if you don't feel well or are concerned about exposure. During this time, there is no need to worry about overdue library materials. There will be no fines for materials returned March 13 – April 30. If you have concerns about being able to pick up your materials on hold, please contact the library for options.
